# COBBLESTONE TOWNHOMES HOA BOARD MEETING

February 10, 2021

Minutes of the Board Meeting of the Cobblestone Townhomes HOA, Pagosa Springs, CO, held by Zoom at 4pm MST.

# I. CALL TO ORDER

Board VP Dick Roberts called the meeting to order.

#### II. ROLL CALL

- A) DIRECTORS: Kristin McCollam; Dick Roberts; Bruce Stewart (joined shortly after Roll Call)
- B) HOMEOWNERS: Kristin McCollam #1, Tammy Walters and Dina Jackson #3, Dick and Cathy Roberts #5, Roberts Nuttal #7, Bruce Stuart #8, Anthony & Crystal Perry #15

# III. PROOF OF NOTICE OF MEETING

Kristin McCollam sent notice of the meeting by email on February 8 to all directors and owners. A proposed annual schedule was also sent on February 1.

### IV. APPROVAL OF MINUTES

Kristin McCollam moved to approve, Dick seconded, and the motion was unanimously approved.

#### V. ELECTION OF OFFICERS

Dick Roberts moved, and Bruce Stuart seconded to approve the following officers: Kristin McCollam, President; Dick Roberts Vice President/Secretary; Bruce Stuart Treasurer. The motion passed unanimously, and Kristin took over as chair of the meeting.

### VI. MANAGER'S REPORT

- A) Tammy Walters presented ice issues with #1, 2, 3, 10, 11, 12, 13, 14 and 15. There was a consensus to get advice from an expert.
- B) Tammy will inform #2 that a warning sign needs to be posted for renters regarding ice issues on the patio.
- C) The removal of the two dead tree behind #9 will take place at the end of April, pending available budget.
- D) On May 8, we will hold a community potluck. Prior to the potluck, we welcome volunteers to help with spring clean up/landscaping.
- E) Discussed requiring the STR managers to give Tammy their phone numbers so she can contact the managers directly when problems arise.

- F) Discussed the problems with STR trash cans. Anthony # 15 is trying a new process whereas his property manager removes the trash therefore he has no other trash pick up.
- G) The fence along the north side of Cobblestone will be completed with the weather permits.

### VII. OLD BUSINESS

- A) Still working on the fine schedule. Discussed fines for trash problems and large vehicles blocking the street.
- B) Discussed insurance; the amounts the HOA have are enough. Mentioned that STR owners need to have an STR rider.
- C) Discussed the need to update and simplify the governing documents since the development phase is over and to address STRs.
- D) BWD will replace the tree in front of #1.

#### VIII. FINANCE

- A) Bruce reported that we will have a special assessment March 1, 2021, for the attorney's fees regarding the hot tub in #2 (see attachment for each unit amount).
- B) A second special assessment of \$500 per unit will be made effective on September 1, 2021, for the state-required back flow preventor. Thanks to Tammy for obtaining a substantially lower quote than the first projected amount.

#### IX. ARCHITECTURAL REVIEW COMMITTEE REPORT

- A) We need to emphasize to owners that Article 10 requires board approval for exterior or drastic interior changes.
- B) Bruce wants to add an antenna on roof of #8 for the high-speed internet. He will put it in writing and present it to the board.

#### X. WEBSITE

Kristin and Tammy are working on updating the website to include all information about Cobblestone an owner might want to know.

### XI. NEW BUSINESS

We will have meetings as needed on the second Wednesday of every month at 4:00 pm MST.
