IV. APPROVAL OF MINUTES

V. MANAGER'S REPORT

- A) Landscaping The temperature will be in the 90's next week. Homeowners are asked to water plants in the flower beds for additional water. Several sprinkler heads need replacing. Tammy will get a suggested water schedule out for those who will be home in next few weeks.
- B) Dryer vent cleaning The person who does it charges around \$100 per unit. Tammy will send email out for sign up/appointments. Lauren Phillips said they blew theirs out and it wasn't easy—blew out a lint ball the size of a football, so cleaning is definitely called for!
- C) Firewise The fire department doesn't do inspections. A nonprofit organization does them and has been contracted to inspect our 16 unit community.

VI. OLD BUSINESS

- A) Water leak/Water Bill & Simple Sub Water meter The system should last 7 years, attaches to the outside of pipes without altering or damaging the pipes, and works on a cell phone connection provided by the manufacturer as part of its monthly monitoring charges. Kristin McCollam moved to use reserve funds to purchase 17 or 18 units and reimburse the reserves with a special assessment. Dick Roberts seconded, and the motion was unanimously approved. Noted that we'll need a policy for turning off water in units that have water leaks.
- B) Roof repair The roofer should be out on July 24 to replace shingles and other roof repairs.

- A) Reserve investment Kristin McCollam moved to move \$50,000.00 from the reserve fund to First Southwest Bank CD at 4.25% for six months unless a better option has been found. Dick Roberts seconded, and the motion was unanimously approved.
